## NOCCC Financial Terms & Conditions

1. Payment can be made with checks. Checks should be made payable to **NOCCC**. One check can pay for one applicant only.
2. Payment can be also made electronically via **Zelle** payable to [NOCCC.Choir@gmail.com](mailto:NOCCC.Choir@gmail.com). Use one transaction for one applicant only.
3. Cancelled personal checks are the receipts for payments. When there is a dispute, the member has the burden of proof of payment.
4. Checks received by NOCCC might be deposited immediately or up to 3 months.
5. Applicant who does not pass audition will receive full refund.
6. There will be a \$30 fee for a returned check and the delinquent payment is due immediately. A late payment fee of \$15 will be charged if payment is not made within 14 days after a written notice or an e-mail notice of payment due is sent. If payment is not made within the 14 day period, NOCCC reserves the right not to provide, or to discontinue, its service to this member.
7. A registration is invalid and incomplete without payment of the membership fee to NOCCC. NOCCC's refund policy is as follows:
  - 100% minus a \$15 non-refundable processing fee if withdrawal is after the 1<sup>st</sup> rehearsal for new enrollment.
  - 100% minus a \$15 non-refundable processing fee and \$30 per rehearsal (including absence in between) if withdrawal is on or before the fourth rehearsal,
  - No refund after the fourth rehearsal
  - Refund request must be made in writing and refund is based on the date the request is received or the last day of attendance, whichever is later
8. Any member who registers after rehearsals start is required to pay the full membership fee. The fee will not be prorated.
9. NOCCC reserves the right not to provide its service, or to discontinue its service to, anyone. Any such decision will be reviewed and approved by the Board of Directors. A member whose membership is so terminated by NOCCC will receive a prorated refund of the membership fee without any processing fee.
